Registration is limited to P/TSO authorized delegates and National Interest Group Member authorized delegates, per Section 3.9 of the By-Laws. Registration for the AM will be open to Member representatives beginning August 25th, 2025, and closing on September 19th, 2025, at 5:00 p.m. EST. You must register prior to this date to ensure voting privileges at the AM. Please note that without exception, any outstanding membership dues or lists must be received prior to attending the meeting to ensure that the provinces are in good standing.

UPDATES TO TAEKWONDO CANADA BY-LAWS

There will be two proposed Resolutions relating to the Taekwondo Canada By-Laws. As approved by the TC Board, TC proposes the following changes to our bylaws:

1. Resolution #1

To clarify the voting cycles and blocks of the biennial election of directors' positions.

2. Resolution #2

To add consecutive term limits to the Director positions on the Taekwondo Canada Board (consistent with the Canadian Sport Governance Code).

ELECTION OF ATHLETE DIRECTOR

In March 2025 the members adopted revisions to the Taekwondo Canada By-Laws to create a new Athlete Director position on the Board of Directors. In April the Senior National Team Athletes were invited to participate in a formal nomination process to determine their nominee for this position. The process was facilitated by AthletesCAN, and the voting was independently managed by Sport Law. The Senior National Team Athletes selected Jordan Stewart as their nominee for the position. At the upcoming AGM, the members will be asked to ratify/affirm this selection and officially elect Jordan Stewart to the Athlete Director position. The term for this position aligns with the By-laws.
